- The annual turnover of the bidder for any one of the financial years 2022-23, 2023-24 and 2024-25 must be a minimum of Rs. 10,00,000.00 (Ten Lakhs), turnover to prove that the firm is financially sound. It will be mandatory to attach proof of this.
- The bidding firm must attach an affidavit to the effect that “the work allotted to their firm will not be Petty Contract”.




